FLEA MARKET SET UP

1. By the Day

You may set up anywhere on the blacktop unless the space is marked 'reserved'. Pull your vehicle up to the space and set up your display. One of our Team members will be along later to collect payment. To reserve a space in advance, or a pavillion space, call 330-877-9860, email info@hartmp.com, or visit customer service at the Hartville MarketPlace anytime prior to the day of the market.

2. By the Month

You may reserve your space for an entire month or longer. To secure your spot, call 330-877-9860, email info@hartmp.com, or visit customer service at the Hartville MarketPlace. Benefits of monthly reservations include \$1 off per space per day and ensuring you have the same space every day of the month. Spaces are held until 9:00 AM. After 9:00 AM that space may be sold to the next available vendor.

OUTDOOR VENDING RULES & REGULATIONS

- Vendors must not drive stakes, nails, etc. into the blacktop.
- Anyone causing a disturbance in this market will be escorted from the grounds.
- Use of obscene language or gestures will not be tolerated.
- Vendors must clean their spaces at the end of the day. Trash must be placed in the garbage compactor or in the open top dumpsters. The compactor is located between the pavilions and there are open top dumpsters between the pavilions and in the south vendor lot. Cardboard (except waxed cardboard) must be placed in the cardboard baler under the overhang by the building entrance. Cardboard boxes must be broken down flat. Vendors are to dispose of only a minimal amount of trash in HMP's facilities. If the vendor does not comply with these requirements, they will be subject to a fine.
- Vendors are not to use the trash barrels in the aisles – they are for shoppers ONLY! If a vendor leaves trash in a space, a minimum cleanup charge of \$30 per space will be assessed to the vendor. Open top dumpsters are provided for you convenience.
- No sale of dogs, cats, birds or any other live animals.
- All vendors intending to sell any type of firearms must register at the office before setting up and must have registration on display for staff to see. All firearms must have a tamper proof trigger lock installed (example: zip tie, trigger lock, etc).

• Hartville MarketPlace and Flea Market reserves the right to refuse admission to any seller and to inspect all merchandise. Any dealer found in possession of illegal goods will be removed from the market and the authorities will be contacted.

• We do not support the sale of Confederate Flags or Merchandise.

• Pornography is prohibited. All items sold or displayed must comply with HMP's strict standards in order to maintain a wholesome family environment.

• Absolutely NO tobacco items or liquor sales.

• No games of chance, skill or raffles are allowed without approval of management.

• No soliciting or walking sales.

• No sale of concession-type or individual bottles and/or cans of beverages.

• All vendors must keep their displays out of the aisles.

• Subleasing of a space is not permitted.

• Sellers agree to be responsible for any and all injuries or damages to persons or property arising from occupancy of space or seller's activities.

• No merchandise, awnings, piping or tables can be left overnight.
